Yokohama International School Fund HOW TO GIVE FORM



This document outlines how donors can support the charitable purposes of Yokohama International School with U.S.-based assets by making tax-deductible contributions to Give2Asia. Donors with Hong Kong assets should contact Give2Asia to receive additional information about making a Hong Kong tax-deductible donation.

Please note: By law, Give2Asia is required to retain discretion and control over the use of donations to accomplish its charitable programs, which includes the Yokohama International School Fund. This means that Yokohama International School must remain charitable in purpose and demonstrate the charitable use of funds in order to receive grants from Give2Asia.

Background & Tax Deductibility

Give2Asia is honored to work with Yokohama International School to connect with its U.S. supporters. **Gifts** for the Yokohama International School Fund at Give2Asia are tax deductible to the extent allowed by U.S. law. Give2Asia is recognized as a tax-exempt public charity in the United States (ID# 94-3373670).

According to the IRS as of the drafting of this form, **"In general, cash contributions to charitable** organizations like Give2Asia may be deducted up to 60 percent of adjusted gross income, with lower adjusted gross income limits for other kinds of contributions." Give2Asia does not offer tax advice and recommends you speak with a financial advisor to understand how best to structure your gift for maximum tax benefit.
